Sir/Madam,

The Eastern Regional Committee in its 184th ERC Meeting held on 24th – 25th March 2015, After considering the records available in the file, and relevant provisions of the NCTE Act 1993, Rules, Regulations and guidelines issued by NCTE Hqrs. the Committee observed as under:

The Principal of the College has requested vide letter dated 26.02.2015 for Change of Nomenclature from College of Teacher Education (CTE) to Institute of Advanced Study in Education (IASE) and requesting for Inserting Change of name in Recognition Letter of NCTE for B.Ed and M.Ed Courses.

The need for change of nomenclature has arisen due to up-gradation of the Institute by the MHRD, Teacher Education Approval Board, New Delhi. The change has been endorsed by:

- (i) The University Grants Commission vide letter F.No.8-133/2005 (CPP-1C) dt.10th October, 2013.
- (ii) Mizoram University vide letter No.MZU/ CDC-1/3/12/882 Dt.10th December, 2012.
- (iii) Government of Mizoram vide Notification Memo No.B.19020/3/2012-THE (CTE) Dt.14th June, 2013.

In view of the above it was decided as under :

As per the request of the institution and as per the approval of the University Grant Commission and Mizoram University, Govt. of Mizoram, the change of nomenclature of the college from "College of Teacher Education (CTE) to Institute of Advanced Study in Education (IASE) is accepted.

2. In view of above decision of ERC, the change of nomenclature of the college from "College of Teacher Education (CTE) to Institution of advanced Study in Education (IASE) is accepted.
